
This is a Written Reprimand for a violation of Department of Management Services Personnel Management System Disciplinary Standards 60L-36.005(3) as defined by State of Florida Employee Handbook Standards of Conduct #f. (# 6.) Conduct Unbecoming a Public Employee: Employees shall conduct themselves, on and off the job, in a manner that will not bring discredit or embarrassment to the State. This action is taken in accordance with Rule 60L-36.005(3), Florida Administrative Code and the State of Florida Employee Handbook, Standards of Conduct. You have acknowledged receiving a copy of the above-named Handbook containing the Standards of Conduct on 4/28/2000.

This Written Reprimand is the result of the following actions, which violated the State of Florida Employee Handbook, Standards of Conduct. On 25 July 2006 while you were off duty, in your privately owned vehicle, and in civilian clothes, you were arrested and charged with Driving While Under the Influence. You have not been adjudicated with reference to this charge; however, as a Detention Superintendent and public servant your actions are in violation of established standards of conduct.

This reprimand is given to you in an effort to correct the above unacceptable behavior. By helping you to correct the above referenced behavior, we feel that you will become a better employee, will serve our customers more faithfully and will become a better role model for the youth under our charge.


